

EU-Brazil R&D Cooperation

Since the 1990s, Brazil has strongly increased its workforce in Research and Development (R&D), and scientific production is growing rapidly. Brazil now accounts for 2% of the scientific papers published worldwide.

Brazil is a strong player in R&D, such as on Biofuels, Off-shore Oil Extraction and Aeronautics. Further priority areas of Brazilian R&D are Applied Biology and Ecology.

Both Brazil and the EU recognize the importance of enabling mutual participation in their research programmes and infrastructure. Reciprocal access conditions are the basis of a fair cooperation in R&D.

The EU has opened its Seventh Framework Programme for Research and Technological Development (FP7) to the participation of Brazilian researchers. As an ACCESS4EU project directed at Brazil, APORTA wishes to point at cooperation opportunities for EU researchers in Brazilian R&D programmes.
